**[PROPOSED] ORDER GRANTING
PLAINTIFFS' MOTION FOR
ATTORNEYS' FEES, COSTS, AND
CLASS REPRESENTATIVE
SERVICE AWARDS**

21 On June 29, 2023, this Court heard Alabama Doe 1, Alabama Doe 2, Indiana Doe,
22 Missouri Doe, and Florida Doe (collectively, "Plaintiffs" or "Class Representatives")
23 motion for motion for attorneys' fees, costs, and class representative service awards. This
24 Court reviewed (a) the motion and the supporting papers; (b) any objections filed with or
25 presented to the Court; (c) Plaintiffs' and Gilead's ("Defendant") (collectively, "the
26 Parties") responses to any objections; and (d) counsels' arguments. Based on this review
27

1 and the findings below, the Court finds good cause to grant the motion.

2 1. An award of \$1,333,333.33 (one-third of the Settlement Fund) in attorneys'
3 fees to Co-Lead Class Counsel is fair and reasonable in light of the nature of this case,
4 Class Counsel's experience and efforts in prosecuting this Action, and the benefits obtained
5 for the Settlement Class.

6 2. An award not to exceed \$31,000 for reimbursement of Co-Lead Class
7 Counsel's documented out-of-pocket costs is fair and reasonable.

8 3. A service award to Plaintiffs Alabama Doe 1, Alabama Doe 2, Indiana Doe,
9 Missouri Doe, and Florida Doe, in the amount of \$5,000 (each) is fair and reasonable in
10 light of Plaintiffs' risks in commencing this Action as Class Representatives, the time and
11 effort spent by Plaintiffs in developing and litigating this Action as the Class
12 Representatives, and Plaintiffs' public interest service.

13 **IT IS HEREBY ORDERED THAT:**

14 1. **Attorneys' Fees and Costs.** Co-Lead Class Counsel is awarded \$1,333,333.33
15 in fees and up to \$31,000 for reimbursement of Co-Lead Class Counsel's
16 documented out-of-pocket costs, to be paid from the Settlement Fund pursuant
17 to paragraphs 1.1.N and 7.1 of the Settlement Agreement.

18 2. **Service Award.** Plaintiffs Alabama Doe 1, Alabama Doe 2, Indiana Doe,
19 Missouri Doe, and Florida Doe are awarded \$5,000.00 (each) as a service award
20 to be paid from the Settlement Fund in accordance with paragraphs 1.1.N and
21 7.2 of the Settlement Agreement.
